## **Open Discussion Items**


- CVE Board CNA Liaison Update Christine Deal
  - Throughout the month of December, the CVE Program Secretariat accepted nominations for the CVE Board CNA Liaison position; the CNA Liaison is responsible for acting as a representative of the CNA community to the Board. This position is a two-way conduit for CNAs to bring things to and from the Board in an official capacity.   - Tod Beardsley was the only nominee for the Board Liaison position; therefore, he is the only candidate on the ballot.
  - On January 4, 2022, the Secretariat initiated the vote for the CNA Liaison position; voting period ends on January 18.
  - 30+ votes received from the CNA community thus far.
- CVE Board Meeting call-in platform (Team, Zoom, etc.) Jo Bazar
  - At the beginning of the COVID pandemic, the CVE Board had no objections to trying other conference tools (Skype was being discontinued). For the past year or so, MS Team has been used for most of the CVE Program meetings, Workshops, CVE Summits, etc. During this time period, MS Team has been satisfactory for the most part, but has been challenging for larger forums. The Secretariat proposed for 2022, piloting Zoom.gov for the CVE Board meetings beginning with the next meeting, January 19, 2022.
